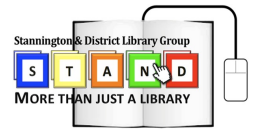

FRIENDS OF STANNINGTON LIBRARY



Since STAND took on running the library in 2014, Sheffield Council has partly funded our running costs. The council's contribution has decreased over the years but we hope they will continue to support us in years to come. This means that Stannington Library is becoming increasingly dependent on donations, fund-raising events and other grant income to meet the shortfall in the £1,500 per month we currently need to run the library.

By signing up as a Friend of Stannington Library you will:

- Become a member of Stannington and District Library Group and at the AGM can influence how the library develops in the future.
- Contribute to our long-term sustainability
- Be part of a community that encourages reading

Become a Friend by donating a minimum of £2 per month or £20 per year. You can donate by using the attached Standing Order form. Please give your contact details opposite. Please sign the gift-aid declaration if you are able.

Paying by Standing Order means that your membership will be renewed each year without any need for action on your part. The advantage of a Standing Order is that you control it – you can cancel it at any time. You control when it is paid and how much. You can pay monthly, quarterly or annually. It will be paid on the same date until you change or cancel it. Unlike a Direct Debit, the library can't change your Standing Order- only you can. You can set up a Standing Order through your online banking or we can post direct to your bank by using the Standing Order form attached.

GIFT AID

If you are a UK tax payer we are able to reclaim 25p in tax from the HMRC for each £1 you donate. This doesn't cost you anything. We are only able to claim this Gift Aid if you show your agreement by signing the Gift Aid declaration on the form. You must be a UK tax payer for your donation to qualify for Gift Aid.

Data Protection

The personal data we collect is only used to enable us to record your subscription membership. It is stored securely, not used for any other purpose, and we will never share it with anyone else. By giving us the information requested, you consent to our using it for the above purpose.
